#### **EXECUTIVE COMMITTEE MEETS**

The executive committee of ALAIR met on Tuesday, October 19, at 10:00 in Montgomery. Several matters were discussed, and the highlights are outlined below.

ALAIR Goals: The goals for the year were accepted and are listed on page 4 of this newsletter.

Constitution/By-laws: The constitution review committed headed by O'Neal Smitherman suggested changes to the ALAIR consitution and by-laws which correct previous inconsistencies. Copies will be mailed to the membership before the annual conference in April.

New AIR paper session: AIR is implementing a new forum session called "Best Presentations from State Conferences," which is designed to provide an opportunity for institutional researchers to attend and present at a national conference. The ALAIR executive committee has selected Allen Smith's (JSU) presentation on "Use of College BASE for Assessing General Education" for nomination for this session.

Train the Trainer: The executive committee will nominate Dr. O'Neal Smitherman to participate in AIR's Train the Trainer program which prepares attendees to return to their states/institutions and share what they have learned at the AIR-sponsored professional development workshop.

Transfer Data Advisory Committee: The committee has been successful in getting participation from some four-year institutions on providing reports on transfers from two-year institutions. They are continuing to work on getting ALL institutions to participate. The feedback from the two-

years receiving the reports has been positive.

Annual Conference: Planning is underway and Judy Miller, vice president and program chair, wants to encourage paper and presentation proposals. (See related article on page 1!)

## NOMINATIONS FOR SUTTON AWARD BEING ACCEPTED

The ALAIR Awards Committee is soliciting nominations for the Joseph T. Sutton Leadership Award. The award was established in 1992 to honor Alabamians who have demonstrated leadership and outstanding accomplishment in institutional research and related fields. The first award was presented to Dr. Gerald Leischuck of Auburn University.

Eligible recipients must at some time have been involved in institutional research or a related field in Alabama and meet one of the following criteria:

- Service to ALAIR, SAIR, or AIR in the form of serving as an officer, committed member, or conference host; making presentations; and other forms of volunteer activity;
- A career in institutional research or a related field exemplifying leadership, accomplishment, and innovation; or
- Contribution to the field of institutional research through specific accomplishments and innovative endeavors which enhance the field, institution, or community (local, state, or nation).

All nominations should include the nominee's name, brief professional history, and a brief statement regarding why you are nominating the individual. Nominations should be submitted by January 14, 1994 to Dr. Al Searway, Director of Planning and Analysis, Jacksonville State University, Jacksonville, AL 36265. The award will be presented at the annual meeting in Huntsville in April.

The Executive Committee adopted the following goals for the association for the coming year:


